"My dad spent countless hours volunteering at the AWA and while he loved all animals, cats were at the top of the list," says Ken Morgan, an AWA board member since 2018. "This is a great way to honor my father and give back to an organization that meant so much to him. He felt strongly in AWA's mission and I'm proud to follow in his footsteps." In addition to being an active member of the AWA, Ken Morgan also took his father's lead when it came to his career.
